## A BILL

To amend the Homeland Security Act of 2002 to require the Administrator of the Federal Emergency Management Agency to provide guidance and coordination for mass fatality planning, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Mass Fatality Plan-  
5 ning and Religious Considerations Act”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

1           (1) Emergency preparedness often plans for  
2           how to prepare and provide for survivors of a nat-  
3           ural disaster, act of terrorism, or other man-made  
4           disaster, but fails to plan for how to prepare for and  
5           respond to mass fatalities that result from such an  
6           incident.

7           (2) Funeral homes, cemeteries, and mortuaries  
8           could be overwhelmed should mass fatalities arise  
9           from a natural disaster, act of terrorism, or other  
10          man-made disaster.

11          (3) Different religions have different customs  
12          surrounding death; for example, the Jewish and  
13          Muslim religions call for burial of the deceased not  
14          later than 48 hours after death.

15 **SEC. 3. PREPAREDNESS FOR MASS FATALITIES RESULTING**  
16                                   **FROM A NATURAL DISASTER, ACT OF TER-**  
17                                   **RORISM, OR OTHER MAN-MADE DISASTER.**

18          Section 504 of the Homeland Security Act of 2002  
19          (6 U.S.C. 314) is amended by adding at the end the fol-  
20          lowing new subsection:

21          “(c) **PREPAREDNESS FOR MASS FATALITIES.**—In  
22          carrying out this section, the Administrator shall provide  
23          guidance to and coordinate with appropriate individuals,  
24          including representatives from different communities, pri-  
25          vate sector businesses, non-profit organizations, and reli-

1 gious organizations, to prepare for and respond to a nat-  
2 ural disaster, act of terrorism, or other man-made disaster  
3 that results in mass fatalities.”.
