

## ATTACHMENT A

On or about October 23, 2012, in Union County, in the District of New Jersey, and elsewhere, defendant

NICHOLAS G. SYSOCK

did knowingly possess material that contained at least three images of child pornography, as defined in Title 18, United States Code, Section 2256(8), which images were shipped and transported using any means and facility of interstate and foreign commerce and in and affecting interstate and foreign commerce by any means, including by computer, and that were produced using materials that were shipped and transported in interstate and foreign commerce, by any means, including by computer.

In violation of Title 18, United States Code, Section 2252A(a)(5)(B) and 2252A(b)(2) and Title 18, United States Code, Section 2.

## ATTACHMENT B

I, Ann M. Kolczynski, am an Inspector with the United States Postal Inspection Service (“USPIS”). I have knowledge of the following facts based upon both my investigation and discussions with other law enforcement personnel and others. Because this affidavit is being submitted for the sole purpose of establishing probable cause to support the issuance of a complaint, I have not included each and every fact known to the government concerning this matter. Where statements of others are set forth herein, these statements are related in substance and in part. Where I assert that an event took place on a particular date, I am asserting that it took place on or about the date alleged.

1. On multiple instances between on or about May 15, 2008 and on or about March 17, 2011, defendant NICHOLAS G. SYSOCK purchased multiple products, including DVDs, photo CDs, and written materials, from a foreign movie production company (the “Company”), which was known to produce and distribute child pornography. Based upon a review of the Company’s customer database records, all of SYSOCK’s orders were placed via the Company’s online ordering system using an email address associated with SYSOCK. The orders were billed and shipped to SYSOCK’s personal residence in Rahway, New Jersey (“Residence”). According to the Company’s customer database records, the orders were shipped via the U.S. mails to SYSOCK’s Residence.

2. Four of the DVDs that SYSOCK purchased and which contained child pornography are described in the chart below along with the title of the DVD and the date on which the DVD was purchased:

“Water Wiggles Going Commando: Boy Fights XI”	7/8/2008	The movie begins with two prepubescent boys dressed in white underwear entering an inflatable pool containing a small amount of water. The pool is located indoors. The boys begin to wrestle and pull each other’s underwear off, so that they are completely naked. They continue to wrestle each other in the inflatable pool, and play with various objects including an inflatable float and a plastic ball. The boys towel off and then proceed to empty the water from the pool and dry the pool. Throughout these segments, the boys are completely naked and their genitals are displayed to the camera. At the end of the movie, the two prepubescent boys are standing naked facing the camera. The English subtitles indicate that the

		interviewer asks the boys their names and ages. The boys indicate that their ages are 13 years old and almost 13 years old.
"Extremely Sticky Water Wiggles Going Commando: Boy Fights XIII"	9/1/2008	The movie begins with two prepubescent boys entering an inflatable pool containing a small amount of water with black trash bags wrapped around their lower bodies. The pool is located in an indoor area that appears to be a kitchen. The two boys pull the black trash bags off each other so that both are completely naked. The boys begin to wrestle and engage in play in the pool. At various points throughout the wrestling scenes, the boys have their legs spread in a manner so as to expose their genitals to the camera. The two boys then pour several substances -- which appear to be chocolate syrup, whipped cream and flour -- over themselves and continue to wrestle each other. Both of the boys are completely naked throughout this segment, and their genitals are often visible to the camera. The two boys are then shown together in the shower where they are washing the food substances off of their bodies.
"Igor"	2/3/2009	The movie begins with several prepubescent boys at an amusement park. The next scene features the boys in the shower playing the game commonly known as "Twister" in which the boys contort and intertwine their bodies. During the shower segment, the boys are naked and their genitals are displayed to the camera. The movie then reverts back to the amusement park. After a short time, four to five prepubescent boys are depicted in a spa-type setting. The boys undress until they are naked, and then proceed to the shower. They again are seen playing "Twister," and their genitals are exposed to the camera. The boys are then depicted sitting naked on a couch. They are sitting with their legs spread so that their genitals are displayed to the camera.
"Raw Rewind"	3/17/2011	Three movie files from the DVD were reviewed. The first movie file features three prepubescent boys. The three boys remove all of their clothing and walk to an indoor pool where they engage in play and swim naked.

		<p>Throughout this segment, the boys are naked and their genitals are exposed. The three boys then proceed to a couch. The boys remain naked and two of the boys are depicted providing the other prepubescent boy with a massage. The movie file then reverts to a scene with four prepubescent boys in the shower, sitting on a couch, and sitting in a sauna with each other. During this segment, all of the boys are naked and their genitals are exposed to the camera. The second movie file features four prepubescent boys who are depicted playing and swimming in the indoor pool. The four boys are also depicted in the shower, sitting in the sauna, and sitting on a couch. All of the boys are naked and their genitals are plainly visible to the camera. In the third movie file, three prepubescent boys are interviewed while sitting on a couch. They are naked and their genitals are exposed. The English subtitles indicate that the interviewer asks the boys their names and ages. The boys indicate during the interview that their ages are 11 years old, 12 years old, and 12 years old, respectively.</p>

3. On October 23, 2012, law enforcement officers executed a search warrant at SYSOCK's Residence in Rahway, New Jersey. At the Residence, law enforcement recovered the four DVDs described above.

4. Additionally, at SYSOCK's Residence, law enforcement discovered a folder that was located in a locked drawer in a desk. The folder contained three printouts from websites on the internet. Included on the printouts were screenshots that contained images of child pornography, as defined by Title 18, United States Code, Section 2256(8). A description of the printout pages and images follow below:

ITEM	DESCRIPTION
1	The header of this printout shows an internet website address, and has an image at the bottom of the page depicting a prepubescent boy with brown hair lying naked on his back. The child's arms are raised and his legs are spread to expose his anus.
2	The header of this printout shows an internet website address, and has an image at the top of the page depicting two prepubescent boys with brown hair lying naked on their backs next to each other on a bed. The child on the left has his left arm folded behind his head and his right hand is touching his exposed penis. His legs are bent, exposing his anus. The child on the right, is lying on his back with his

	legs bent, exposing his anus.
3	The header of this printout shows an internet website address, and has an image with a stamp on it that reads: boykiss.com. The image depicts a prepubescent male with brown hair lying naked on his back in a black chair. The child's hands are under his legs and are touching his buttocks. His legs are bent and in the air, exposing his anus.

5. During and after the search of the residence, and after being advised of his Miranda rights, SYSOCK admitted to law enforcement officers, among other things, in substance and in part, that: (1) he purchased the four DVDs described above in Paragraph 2 from the Company; and (2) he downloaded the images described above in Paragraph 3 and retained them in a locked drawer in a folder in his desk.

6. Based upon my education, training and experience, and my discussions with other law enforcement officers, and to the best of my knowledge, the DVDs described in Paragraph 2 above were shipped and transported using any means and facility of interstate and foreign commerce and in and affecting interstate and foreign commerce by an means, including by computer, and were produced using materials that were shipped and transported in interstate and foreign commerce, by an means, including by computer, based upon, among other things, my review of the Company's customer database records and the presence of the DVDs in SYSOCK's Residence. Additionally, based upon my education, training and experience, and my discussions with other law enforcement officers, and to the best of my knowledge, the images described in Paragraph 3 above were shipped and transported using any means and facility of interstate and foreign commerce and in and affecting interstate and foreign commerce by an means, including by computer, and were produced using materials that were shipped and transported in interstate and foreign commerce, by an means, including by computer.
